## PATENT ASSIGNMENT

This **PATENT ASSIGNMENT** (this “**Patent Assignment**”) is entered into and effective as of this 10th day of February, 2021, by and between Pureport, Inc., a Delaware corporation (“**Pureport**” or “**Assignor**”), in favor of Digital Porpoise, LLC, a Delaware limited liability company (the “**Assignee**”). All capitalized terms used herein and not otherwise defined herein shall have the meaning ascribed to such terms in that certain Asset Purchase Agreement, dated as of February 3, 2021 (the “**Purchase Agreement**”) by and among Pureport, the Assignee, and Digital Realty Trust, Inc., a Maryland corporation.

### RECITALS:

**WHEREAS**, pursuant to the Purchase Agreement, Pureport and/or certain of its Affiliates agreed to assign to Assignee all right, title and interest in and to (i) the patents and patent applications set forth on **Schedule 1** and the inventions claimed therein, (ii) all related continuations, continuations-in-part, divisionals, reissues, re-examinations, substitutions, and extensions thereof, and (iii) all benefits, privileges, causes of action, and remedies relating thereto throughout the world (collectively, the “**Assigned Patents**”).

**NOW, THEREFORE**, in consideration of the foregoing and the respective representations, warranties, covenants, agreements and conditions set forth herein, and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, and intending to be legally bound hereby, each party hereto hereby agrees as follows:

1. **Assignment.** Assignor hereby sells, assigns, transfers, conveys and delivers unto Assignee all right, title and interest in and to the Assigned Patents, to be held and enjoyed by Assignee to the full end of the term for which said letters patent may be granted, as fully and entirely as the same would have been held and enjoyed by Assignor had this assignment and sale not been made; and Assignor hereby assigns to Assignee all rights to sue for infringement, including past infringement if any, of any Assigned Patents or any patent based upon any such Assigned Patents.

2. **Recordation and Further Actions.** Assignor authorizes the Commissioner for Patents of the United States Patent and Trademark Office and any other Governmental Authority to record and register this Patent Assignment upon request by the Assignee. Assignor shall take such steps and actions following the date hereof, including the execution of any documents, files, registrations, or other similar items, to ensure that the Assigned Patents are properly assigned to Assignee, or any assignee or successor thereto.

3. **Successors and Assigns.** This Patent Assignment shall be binding upon and shall inure to the benefit of the parties hereto and their respective successors and assigns.

4. **Entire Agreement.** This Patent Assignment and the Purchase Agreement (including the other schedules and exhibits to the Purchase Agreement) contain the entire agreement of the parties with regard to the subject matter hereof; provided, however, that this provision is not intended to

abrogate any other written agreement between the parties executed with or after this Patent Assignment.

5. **Governing Law.** This Patent Assignment shall be governed, including as to validity, interpretation and effect, by, and construed in accordance with, the internal Laws of the State of Delaware applicable to agreements made and fully performed within the State of Delaware.


