AND, Assignor hereby authorizes and requests the Commissioner of Patents of the United States and any official of any foreign jurisdiction whose duty it is to issue patents, to issue any and all letters patents of the United States or such foreign jurisdiction granted upon the inventions set forth in the Application to Assignee, and hereby covenants that it has full right to convey its entire interest as herein assigned, and that it has not executed any agreement inconsistent herewith and will not execute any agreement inconsistent herewith without Assignee’s consent;


AND, Assignor hereby further covenants and agrees that it shall use reasonable efforts to execute all papers and provide all documents necessary in connection with the United States, international, and foreign applications when called upon to do so by Assignee, its successors and assigns, and assist the Assignee, its successors and assigns, in connection with the Application and any application or patent claiming priority directly or indirectly thereto, including to communicate with Assignee and its successors and assigns, any facts known to it respecting the inventions, and generally do everything reasonably necessary to aid Assignee, its successors and assigns, to prosecute, obtain and enforce patent protection for the Application and related inventions in the United States and any foreign jurisdiction, it being understood that any expense incident to such cooperation and the execution of such papers shall be borne by the Assignee, its successors and assigns, which cooperation shall be given without compensation unless Assignor is required to incur expenses or is required to spend any substantial amount of time providing

assistance under this provision in which case Assignor shall be entitled to compensation at mutually agreed upon rates.
