COVENANT, when requested and at the expense of the ASSIGNEE, to carry out in good faith the intent and purpose of this Assignment, to execute all Related Applications; to execute all rightful oaths, declarations, powers of attorney, assignments, and other papers for the Patent Application and for any Related Applications; to communicate to the ASSIGNEE all facts and provide to the ASSIGNEE all documents and things known and accessible to the ASSIGNOR relating to the Intellectual Property Rights, including, but not limited to, the Improvements, the '248 Application, any Related Applications, and the histories thereof, and to testify as to the same in any interference, derivation, or review proceeding, litigation, or other proceeding relating to the any of the Intellectual Property Rights, including, but not limited to, any of the Improvements, the '248 Application, any Related Application, and/or the history of any of the
