## PATENT ASSIGNMENT AGREEMENT

This Assignment (the “**Agreement**”) is made and entered into effective as of December 1, 2021, by and between Bruno Giannoccaro, an individual residing at Rua Desembargador do vale, 91, Sao Paulo, Brazil 05010-40 (“**Assignor**”), and Functional Patterns Holdings, LLC, a company incorporated in Nevada, with a place of business at 3441 West Sahara Avenue, Suites B3 & B4, Las Vegas, NV, 89102 (“**Assignee**”).

WHEREAS, the inventions disclosed in Exhibit A were invented by Bruno Giannoccaro, are presently owned by Assignor (“**Patents**”), and are covered by Patent Rights as defined below; and

WHEREAS, Assignor is willing to assign full ownership rights, including the right to take proceedings to recover damages and claim all other relief in respect of any acts of infringement thereof whether such acts shall have been committed before or after the date of the assignment or this confirmatory assignment, in all territories from Assignor for all Patent Rights listed in Exhibit A and Assignee is desirous of obtaining said Patent Rights.

### DEFINITIONS

For the purposes of this Agreement, in addition to the words and phrases that are defined throughout the body of this Agreement, the following words and phrases shall have the following meanings:

1.1 “**Affiliate**” means any corporation or other business entity which is bound in writing by Assignor to the terms set forth in this Agreement and in which Assignor owns or controls, directly or indirectly, at least twenty percent (20%) of the outstanding stock or other voting rights entitled to elect directors, or in which Assignor is owned or controlled directly or indirectly by at least twenty percent (20%) of the outstanding stock or other voting rights entitled to elect directors; but in any country where the local law does not permit foreign equity participation of at least twenty percent (20%), then an “Affiliate” includes any company in which Assignor owns or controls or is owned or controlled by, directly or indirectly, the maximum percentage of outstanding stock or voting rights permitted by local law.

1.2 “**Enhancements**” means changes or additions to the subject matter described in the Patent listed in the attached Exhibit A, including all new releases, made by Assignor, that add significant new functions or substantially improved performance, and including related documentation.

1.3 “**Patent Rights**” means Assignor’s rights in any of the following: the US and foreign patent applications enumerated in Exhibit A disclosing and claiming the Patents, filed and assigned to Assignor; any patents issuing on said applications including reissues, reexaminations and extensions; and any corresponding foreign applications or patents; any continuation, continuation-in-part, or divisional application of said utility application; any patent(s) that issue from the foregoing application(s), including any utility patents and models; any patent(s) that issue from the foregoing application(s) and are subjected to inter partes review, supplemental examination, reexamination, reissue, substitutes, any post-grant proceeding, or the like; and any

design registrations granted for any of the inventions or improvements described in the foregoing application(s) or patent(s); all rights in any inventions and improvements that are described and/or claimed in any patents and/or patent applications that claim or are entitled to claim priority to the filing date of any one or more of the foregoing applications and that are filed in accordance with the International Convention for the Protection of Industrial Property, the Patent Cooperation Treaty, the European Patent Convention, and all other treaties of like purpose; together with rights of priority created by such patent applications under any international treaty or convention relating thereto, including any rights accrued by the publication of the applications, such as 35 U.S.C. § 154(d), Art. 67(1), and any rights arising from the invention under laws and conventions protecting copyright, trademark, trade dress, or other industrial property; including the patents and applications listed in Exhibit A.

1.4 “**Territory**” means all countries where the Patents in Exhibit A are obtained.

## ASSIGNMENT

For good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, and intending to be legally bound hereby, Assignor, individually and collectively hereby assigns, transfers, and conveys to Assignee his entire right, title, and interest, without encumbrance, in all Patents Rights in Exhibit A. Assignor represents and warrants that he has not made any agreement with another that would affect the right, title, and interest in such Patents Rights and that Assignee shall exclusively own the entire interest in each of the Patents Rights in Exhibit A.

Assignor agrees that, when requested, he will, without charge to the Assignee but at his own expense, sign all papers, take all rightful oaths, make all rightful declarations, and do all acts which may be necessary, desirable, or convenient for securing and maintaining patents or other forms of protection for the invention(s) in any and all countries, and for vesting title thereto in the Assignee or its successors or assigns.


Assignor agrees to communicate to Assignee or its representatives any facts known to Assignor respecting the invention(s) and, when requested by the Assignee and at its expense, will testify in any legal proceedings, and generally do everything possible to aid Assignee, its successors, assigns, and legal representatives, to obtain and enforce protection for the invention(s) in any and all countries.

Assignor agrees that a copy of this Assignment shall be deemed a full, legal, and formal equivalent of any assignment, consent to file, or like document which may be required in any country for any purpose, and more particularly, in proof of the right of Assignee, or its successors, assigns, and legal representatives to apply for patent or other protection for the invention(s), and to claim the benefits of the right of priority provided by any relevant international treaty or convention relating to any of the aforementioned patent applications.

Assignor covenants with Assignee, its successors, assigns, and legal representatives, that to the best of Assignor’s knowledge, the right, title and interest herein conveyed by the Assignor to

Assignee are free and clear of any encumbrance and that Assignor has the right to sell, assign, transfer, and convey the same.


