WHEREAS, on the terms and subject to the conditions set forth herein, Assignor desires to sell, assign and transfer, and Assignee desires to accept the sale, assignment and transfer of, the patents and patent applications set forth in Schedule A (the "Transferred Patents"),

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties agree as follows:

1. Assignment of Transferred Patents. Assignor hereby sells, assigns and transfers to Assignee, and Assignee hereby accepts the sale, assignment and transfer from Assignor of, all of Assignor's (a) right, title and interest in and to the Transferred Patents set forth in Schedule A, and (b) right to sue for past, present or future infringement of such Transferred Patents and to retain any damages and profits due or accrued for any such past, present or future infringement of such Transferred Patents.

2. Authorization. Assignor hereby requests and authorizes Assignee and any attorney thereof, to insert the serial number or any other identifying information pertaining to the Transferred Patents onto this Agreement deemed necessary for its recordation.



4. Counterparts. This Agreement may be executed in one or more counterparts, each of which shall be deemed an original, and all of which shall constitute one and the same instrument.


