PATENT ASSIGNMENT

This Patent Assignment ("Assignment"), dated as of SEPTEMBER 13, 2018 2018 and effective as of May 18, 2018, is between AbbVie Inc., a corporation organized and existing under the laws of Delaware, having a place of business at 1 North Waukegan Road, North Chicago, Illinois 60064 USA ("AbbVie Inc."), and AbbVie Deutschland GmbH & Co. KG, a limited liability company organized and existing under the laws of Germany, having a place of business at Mainzer Strasse 81, 65189 Wiesbaden, Germany ("AbbVie KG").

WHEREAS, AbbVie Inc. has agreed to assign and transfer to AbbVie KG and AbbVie KG has agreed to accept from AbbVie Inc. the patents set forth on the Patent Schedule A attached hereto.


NOW THEREFORE, in consideration of the premises, mutual covenants and provisions herein contained, the receipt and sufficiency of which is hereby acknowledged, and intending to be legally bound hereby, the parties hereto agree to execute this Assignment, as follows:

- 1.0 Assignment.** AbbVie Inc. has assigned and/or by these presents does hereby assign, transfer and convey unto AbbVie KG, AbbVie Inc.'s whole and entire right, title and interest (i) in and to the inventions claimed in the Patent Schedule A, including any continuation, continuation-in-part, division, renewal, substitute, reexamination or reissue thereof, including any patents obtained based upon a claim of priority to any patent on said AbbVie Inc. Patents and (ii) in and to all rights to sue for and collect damages resulting from past, present and future infringement of said patents in (i).
- 2.0 Enjoyment.** The patents subject to Paragraph 1 shall be held and enjoyed by AbbVie KG, for AbbVie KG's use and benefit, and for AbbVie KG's legal representatives and assigns, to the full end of the term or terms for which same may be granted, as fully and entirely as the same would have been held by AbbVie Inc. had this assignment and transfer not been made.
- 3.0 Assistance.** The parties to this Assignment shall use commercially reasonable efforts to take, or cause to be taken, all actions, and to do, or cause to be done, all things, necessary or advisable to consummate the transactions contemplated by this Assignment. Without limiting the forgoing, each of AbbVie Inc. and AbbVie KG shall cooperate with the other without any further consideration to execute and deliver, or use commercially reasonable efforts to cause to be executed and delivered, all documents as may reasonably be necessary to secure the vesting in AbbVie KG of all rights assigned to AbbVie KG by this Assignment, including without limitation any documents required to record this Assignment with local patent offices.
- 4.0 Counterparts.** This Assignment may be executed in one or more counterparts, all of which shall be considered one and the same document.

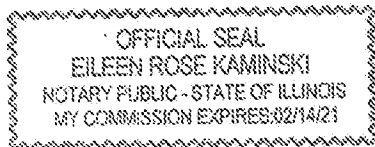


