**TERMINATION AND RELEASE OF SECURITY INTEREST  
IN INTELLECTUAL PROPERTY COLLATERAL**

TERMINATION and RELEASE dated as of January 27, 2022, tendered from NEW JERSEY ECONOMIC DEVELOPMENT AUTHORITY, having an address at 36 West State Street, PO Box 990, Trenton, New Jersey 08625-0990 ("Lender"), to SEMPRAE LABORATORIES, INC., having an address at 12 Post Brook Road North, West Milford, New Jersey 07480 ("Grantor").

WHEREAS, a certain Patent, Trademark and Copyright Security Agreement, dated as of January 9, 2009 (the "PTC Security Agreement"), was made and entered by and between Grantor and Lender;

WHEREAS, pursuant to the PTC Security Agreement, Grantor gave to, and in favor of, Lender a security interest (the "Security Interest") in certain collateral, specifically the Intellectual Property Collateral;

WHEREAS, the PTC Security Agreement was recorded in the United States Patent and Trademark Office on September 7, 2012, as to patents only, and is found at reel No. 028992 frames 0604 through 0610. See attached schedule copied from the PTC Security Agreement; and


WHEREAS, Grantor now desires to terminate and release all of the Security Interest Grantor may have had in the Intellectual Property Collateral.

NOW, THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, and upon the terms set forth in this termination and release, and intending to be legally bound hereby, Lender undertakes the following:

1. Definitions. Unless otherwise defined herein, capitalized terms or matters of construction defined or established in the Security Agreement and in the PTC Security Agreement shall be applied herein as defined or established therein. All other undefined terms contained in this Agreement, unless the context indicates otherwise, shall have the meanings provided for by the UCC to the extent the same are used or defined therein.
2. Release of Security Interest. Lender hereby terminates, releases and discharges the Security Interest in the Intellectual Property Collateral, and any other right, title or interest that Lender might have had in the Intellectual Property Collateral shall hereby cease and become null and void.
3. Further Assurances. Lender hereby agrees to duly execute, acknowledge, procure and deliver any further documents and to do such other acts as may be reasonably necessary to affect the release of the Security Interest contemplated hereby.
