## **TRANSFER STATEMENT**

Dated: March 9, 2010

Pursuant to Section 9-619 of the Uniform Commercial Code (it being understood that the following is intended to constitute a "transfer statement" as defined in said Section), the undersigned, CapitalSource Finance LLC, a Delaware limited liability company, as Agent (the "**Agent**") under that certain Amended and Restated Credit Agreement dated as of March 23, 2007 (as the same has been and further may be amended, restated, supplemented or otherwise modified, the "**Credit Agreement**") among PCS ULTIMATE HOLDINGS, LLC, a Delaware limited liability company ("**Ultimate Holdings**"); PREMIER CARD SOLUTIONS, INC., a Delaware corporation f/k/a PREMIER CARD SOLUTIONS, LLC ("**Holdings**"); A&M WHITAKER ENTERPRISES, INC., an Oklahoma corporation ("**A&M**"); UV COLOR, INC., a Minnesota corporation ("**UV Color**"); UVC INTERNATIONAL, LLC, a Minnesota limited liability company ("**UVC International**"; and, together with Ultimate Holdings, Holdings, A&M and UV Color, the "**Debtors**"; Agent; and the Lenders from time to time parties thereto, and in Agent's capacity as a secured creditor conducting a private foreclosure sale pursuant to Section 9-610 of the Uniform Commercial Code, hereby states, to and for the benefit of CPI Card Group - Minnesota, Inc, a Delaware corporation ("Transferee"), that:

1. The Debtors, pursuant to one or more agreements executed in connection with the Credit Agreement, have pledged to the Agent all of their right, title and interest in and to substantially all of their assets as collateral security for the payment and performance of their liabilities, obligations and indebtedness under, and as defined in, the Credit Agreement.
2. Due to certain breaches of the terms and conditions of the Credit Agreement, Events of Default (as defined in the Credit Agreement) are currently in existence under the Credit Agreement.
3. As a result of the existence of such Events of Default, Agent has elected to exercise its post-default remedies under the Credit Agreement, the agreements related thereto and the Uniform Commercial Code in respect of the Collateral, and in connection therewith Agent has conducted a private foreclosure sale pursuant to Section 9-610 of the Uniform Commercial Code as evidenced by that certain Asset Purchase Agreement dated March 9, 2010 (the "**Asset Purchase Agreement**") between Agent and Transferee and the other agreements entered into in connection therewith.
4. By reason of Agent's exercise of post-default remedies as described in the preceding paragraph, and pursuant to the terms and conditions set forth in the Asset Purchase Agreement and other agreements entered into in connection therewith, Transferee has acquired all rights of the Debtors in and to the Acquired Assets (as that term is defined in the Asset Purchase

Agreement), including, without limitation, the intellectual property assets listed in Exhibit A hereto (the "IP Assets").

5. The name and mailing address of Agent and, to the knowledge of Agent, based on disclosures made under the Credit Agreement (with respect to Debtors) and the Asset Purchase Agreement (with respect to Transferee), the Debtors and Transferee are as follows:
