Assignor further assigns to Assignee or its heirs, successors, assigns, or other legal representatives the whole right, title, and interest in and to the invention throughout all countries foreign to the United States, including the right to (1) file any foreign patent applications claiming priority to the provisional patent application and to otherwise seek any patent in any foreign country; (2) file any divisional, continuation, and continuation-in-part applications claiming priority to the foreign patent application where such

procedure is proper; and (3) seek reissues or extensions of any patent in any foreign country.


