Bugaboo International B.V. further authorizes said ASSIGNEE, its successors and assigns, or anyone it may properly designate, to apply for Letters Patent, in its own name, if desired, in any and all countries, and additionally to claim the filing date of said International Application and any appropriate priority claim and/or otherwise take advantage of the provisions of the International Convention.
