ASSIGNMENT AGREEMENT

NOW THEREFORE, in consideration of valuable consideration, the receipt of which is hereby acknowledged, it is hereby agreed by and between the Parties as follows:

- 1. DSP hereby assigns to Ireland the entire right, title, and interest to the Purchased Assets.
- 2. DSP hereby assigns to Ireland the WMI Agreement, including all rights and obligations contemplated therein.
- 3. Either Party may assign this Agreement or any and all rights and obligations contemplated herein to an affiliate or to a company acquiring substantially all of the assets of such Party to which this Agreement relates without the consent of the other Party. Any such assignment shall be subject to the terms of this Agreement. Subject to the foregoing, this Assignment shall bind and inure to the benefit of the respective Parties hereto and their successors and assigns.




