PATENT ASSIGNMENT

This Patent Assignment, dated as of February 1, 2022 (the "Effective Date"), is made by Inchbug, LLC ("Assignor"), a Texas limited liability company with an address of 9421 Neils Thompson Drive, Austin, Texas 78758, in favor of Flos Lunae, LLC ("Assignee"), a Texas limited liability company with an address of 10202 Pickfair Drive, Austin, Texas 78750, the purchaser of certain assets of Assignor pursuant to an Asset Purchase Agreement between Assignor and Assignee, dated as of February 1, 2022 (the "Asset Purchase Agreement").

WHEREAS, Assignor is the owner of all rights, title, and interests in and to the patent(s) and/or patent application(s) shown on the attached Exhibit A (hereinafter the "Patents");

WHEREAS, Assignee desires to acquire the entire right, title, and interest in and to the Patents and all the inventions and discoveries disclosed in the Patents (the "Inventions"); and

WHEREAS, under the terms of the Asset Purchase Agreement, Assignor has conveyed, transferred and assigned to Assignee the entire worldwide rights, title and interest in and to the Patents, Inventions and related intellectual property rights, and has agreed to execute and deliver this Patent Assignment for recording with governmental authorities, including but not limited to the United States Patent and Trademark Office;

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged:

1. Assignor hereby irrevocably sells, assigns, transfers, and sets over unto Assignee, and Assignee hereby accepts:
 - (a) the entire right, title, and interest in all countries throughout the world in and to the Patents and Inventions, including any renewals, revivals, reissues, reexaminations, extensions, continuations, continuations-in-part, and divisions of said Patents and any substitute applications therefor;
 - (b) the entire right to file patent applications in the name of Assignee or its designee on the aforesaid Inventions in all countries of the world;
 - (c) the entire right, title, and interest in and to any patent which issued and may issue on the Inventions in any country, and any renewals, revivals, reissues, reexaminations, and extensions thereof, and any patents of

confirmation, registration, and importation of the same;

(d) the right to sue and recover for, and the right to profits or damages due or accrued in connection with, any and all past, present, or future infringements of the Patents and Inventions; and

(e) the entire right, title, and interest in all convention and treaty rights of all kinds, including without limitation all rights of priority in any country of the world, in and to the above Patents and Inventions;

2. Assignor hereby authorizes and requests the competent authorities to grant and to issue any and all patents on the Inventions throughout the world to Assignee, its successors, or assigns, whose rights, title, and interests in such patents are the same as would have been held and enjoyed by Assignor had this assignment, sale, and transfer not been made.

3. Assignor hereby covenants and agrees, upon the request of Assignee, and at the Assignee's expense, to testify in any legal proceedings involving the maintenance, preservation or enforcement of the rights of Assignee transferred under the Patent Assignment.

4. The Parties agree that the Patent Assignment will be binding on Assignor and will inure to the benefit of Assignee and each of their respective successors and assigns.

5. The terms of the Asset Purchase Agreement, including but not limited to, the representations, warranties, covenants, agreements and indemnities relating to the Assigned Patents are incorporated here by reference. The parties acknowledge and agree that the representations, warranties, covenants, agreements and indemnities contained in the Asset Purchase Agreement shall not be superseded hereby but shall remain in full force and effect to the full extent provided therein. In the event of any conflict or inconsistency between the terms of the Asset Purchase Agreement and the terms hereof, the terms of the Asset Purchase Agreement shall govern.

6. The laws of the State of Texas shall govern the Patent Assignment and the Parties hereby submit to the exclusive jurisdiction of the State and Federal courts located in Austin, Texas for the purpose of enforcing any claim arising under or in connection with the Patent Assignment.

7. If the Patent Assignment is executed in more than one counterpart, each counterpart shall be deemed to be an original, and all counterparts shall constitute a single agreement. Delivery of a digital image of a signed document shall be

considered equivalent to delivery of the physical document, and the digital image shall be considered the signed document.

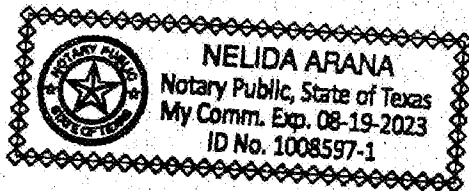

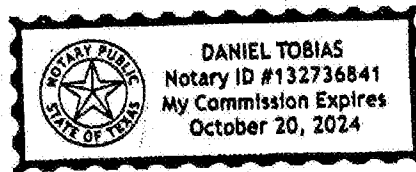
