**FIRST LIEN PATENT SECURITY AGREEMENT**

This **FIRST LIEN PATENT SECURITY AGREEMENT** (as amended, restated, supplemented, waived or otherwise modified from time to time) (this “Agreement”), dated as of January 15, 2021, is entered into by Berry Global, Inc. (the “Company”), certain subsidiaries of the Company identified on the signature pages hereto (such subsidiaries and together with the Company, the “Grantors”) in favor of U.S. Bank National Association, as collateral agent (in such capacity, the “Collateral Agent”) for the Secured Parties (the “Secured Parties”).

**WHEREAS**, the Company, Citigroup Global Markets Inc. and J.P. Morgan Securities LLC, as representatives of the several initial purchasers set forth on Schedule 1 thereto (the “Representatives”) and the guarantors party thereto have entered into a purchase agreement, dated as of January 11, 2021 (as amended, restated, supplemented, waived or otherwise modified from time to time, the “Purchase Agreement”), pursuant to which the Company issued and sold its 0.95% First Priority Senior Secured Notes due 2024 (the “Securities”).

**WHEREAS**, the Securities were issued by the Company pursuant to Indenture dated January 15, 2021 (as amended, restated, supplemented, waived or otherwise modified from time to time, the “First Priority Notes Indenture”) by and among the Company, the guarantors party thereto and U.S. Bank National Association, as trustee (the “Trustee”), the Collateral Agent.

**WHEREAS**, the Company, each subsidiary of the Company identified therein as a party and the Collateral Agent have executed and delivered that certain Collateral Agreement, dated as of the date hereof, in favor of the Collateral Agent (as amended, restated, supplemented, waived or otherwise modified from time to time, the “Collateral Agreement”).

**WHEREAS**, under the terms of the Collateral Agreement, the Grantors have granted a security interest in certain property, including, without limitation, certain Intellectual Property of the Grantors to the Collateral Agent for the benefit of the Secured Parties, and have agreed as a condition thereof to execute this Agreement for recording with the United States Patent and Trademark Office and other applicable Governmental Authorities;

**NOW, THEREFORE**, in consideration of the foregoing and for other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, Grantors and the Secured Parties hereby agree as follows:

SECTION 1. DEFINED TERMS. Capitalized terms not otherwise defined herein have the meanings set forth in the Collateral Agreement.

SECTION 2. GRANT OF SECURITY INTEREST IN PATENT COLLATERAL. Each Grantor hereby grants to the Collateral Agent, for the benefit of the Secured Parties, a security interest in and continuing lien on all of such Grantor’s right, title and interest in, to and under the following, whether now owned or existing or hereafter acquired or arising and wherever located:



(a) all letters patent of the United States or the equivalent thereof in any other country or jurisdiction, and all applications for letters patent of the United States or the equivalent thereof in any other country or jurisdiction, including, but not limited to, the registrations and applications referred to on Schedule A hereto (as such schedule may be amended or supplemented from time to time);

(b) all provisionals, reissues, extensions, continuations, divisions, continuations-in-part, reexaminations or revisions thereof, and the inventions disclosed or claimed therein, including the right to make, use, import and/or sell the inventions or designs disclosed or claimed therein,

(c) all claims for, and rights to sue for, past or future infringements of any of the foregoing, and

(d) all income, royalties, damages and payments now or hereafter due and payable with respect to any of the foregoing, including damages and payments for past or future infringement thereof.

SECTION 3. PRECEDENCE. The security interest granted hereby is granted in conjunction with the security interest granted to the Secured Parties under the Collateral Agreement. The rights and remedies of the Secured Parties with respect to the security interest granted hereby are in addition to those set forth in the Collateral Agreement. In the event of any conflict between the terms of this Agreement and the terms of the Collateral Agreement, the terms of the Collateral Agreement shall control.

SECTION 4. RECORDATION. Each Grantor authorizes and requests that the Commissioner of Patents and any other applicable government officer record this Agreement.

SECTION 5. MODIFICATION OF AGREEMENT. This Agreement or any provision hereof may not be changed, waived or terminated except (i) in accordance with the amendment provisions of the Collateral Agreement pursuant to which (subject to the provisions of the First Priority Notes Indenture and the Intercreditor Agreements) the Collateral Agent may modify this Agreement, after obtaining the relevant Grantor's approval of or signature to such modification, or (ii) by the Collateral Agent amending Schedule A hereto to include reference to any right, title or interest in any existing Patents or any Patents acquired or developed by such Grantor after the execution hereof or to delete any reference to any right, title or interest in any Patents in which such Grantor no longer has or claims any right, title or interest.

SECTION 6. GENERAL.

(a) Governing Law. **THIS AGREEMENT AND THE RIGHTS AND OBLIGATIONS OF THE PARTIES UNDER THIS AGREEMENT SHALL BE CONSTRUED IN ACCORDANCE WITH AND GOVERNED BY THE LAWS OF THE STATE OF NEW YORK.**

(b) Successors and Assigns. This Agreement shall be binding upon and inure to the benefit of the Secured Parties and Grantors and their respective successors and assigns.

No Grantor shall, without the prior written consent of the Secured Parties, assign any right, duty or obligation hereunder.


(c) Counterparts. This Agreement may be executed in any number of counterparts and by the parties hereto on separate counterparts, each of which, when so executed, shall be deemed to be an original and all of which taken together shall constitute one and the same instrument.

(d) Intercreditor Agreements. Notwithstanding anything herein to the contrary, the liens and security interests granted to the Collateral Agent pursuant to this Agreement are expressly subject to the terms of (a) the Senior Lender Intercreditor Agreement (as defined in the First Priority Notes Indenture), (b) the Second Priority Intercreditor Agreement (as defined in the First Priority Notes Indenture) and (c) the Senior Fixed Collateral Intercreditor Agreement (as defined in the First Priority Notes Indenture). In the event of any conflict between the terms of any Intercreditor Agreement and the terms of this Agreement, the terms of the applicable Intercreditor Agreement shall govern.


