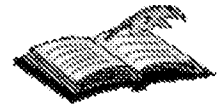

THIS AGREEMENT is dated 18 February 2021

PARTIES

- (1) Equitherm Limited (incorporated and registered under company number: 07651216) having its registered office at 13 Station Road, Kingswood, Bristol, United Kingdom, BS15 4PG (**Assignor**).
- (2) Water-Kinetics Limited (incorporated and registered in Scotland under company number: SC634550) having its registered office at Lomond House, 7 Greenbank Road, Darvel, East Ayrshire, United Kingdom, KA17 0NN (**Assignee**).

BACKGROUND

- A. The Assignor is the proprietor of the granted patents and pending patent applications set out in the accompanying Schedule 1 (**the Patents**).
- B. The Assignor has agreed to assign the Patents to the Assignee on the terms set out below.

1. ASSIGNMENT

In consideration of the sum of £1 sterling (receipt of which the Assignor hereby acknowledges), the Assignor hereby assigns unto the Assignee:

- (a) all interest in and to the Patents and the full and exclusive benefit thereof, and all rights, privileges and advantages appertaining thereto; and
- (b) the right to recover and take all such proceedings as may be necessary for the recovery of damages or other forms of relief in respect of all infringement of the Patents whether taking place before or after the date of this Agreement.

2. PROCEEDINGS

The Assignor agrees and undertakes to provide to the Assignee (at its request) all reasonable assistance with any proceedings which may be brought by or against the Assignee against or by any third party relating to the Patents assigned by this Agreement.

3. **FURTHER ASSURANCE**

The Assignor hereby covenants with the Assignee that the Assignor shall, at the cost and expense of the Assignee, do or procure to be done all such further acts and things, and execute or procure the execution of all such other documents, as the Assignee may from time to time reasonably require in order to give the Assignee the full benefit of the property and rights hereby assigned, whether in connection with any registration of title or other similar right or otherwise.

4. **GOVERNING LAW AND JURISDICTION**

This Agreement and any dispute or claim arising out of or in connection with it or its subject matter or formation (including non-contractual disputes or claims) shall be governed by and construed in accordance with the laws of Scotland.


The parties irrevocably agree that the courts of Scotland shall have jurisdiction to settle any dispute or claim that arises out of or in connection with this Agreement or its subject matter or formation (including non-contractual disputes or claims).
