CONFIRMATORY ASSIGNMENT OF PATENT RIGHTS

This CONFIRMATORY ASSIGNMENT OF PATENT RIGHTS (this "Assignment") is made and entered into as of the date of last signature hereto ("Confirmatory Assignment Effective Date") by and between REVx Technologies, Inc., a Delaware corporation with a place of business at 6824N. NOW, THEREFORE, for good and valuable consideration paid by Assignee to Assignor, the receipt and sufficiency of which are hereby acknowledged, Assignor and Assignee agree as follows:

Assignor hereby irrevocably sells, assigns, transfers, and conveys to Assignee all right, title, and interest in and to:

(a) the Assigned Patents;

(b) all inventions, invention disclosures, and discoveries described in any of the Assigned Patents;

(c) all rights of priority related to the Assigned Patents and rights to apply in any or all countries of the world for patents claiming any inventions, invention disclosures, and discoveries described in any of the Assigned Patents;

(d) all claims, causes of action (whether known or unknown, contingent or noncontingent, accrued or unaccrued, or currently pending, filed, or otherwise), provisional rights, and other enforcement rights under, or on account of, any of the Assigned Patents, including all (i) rights to



pursue damages, injunctive relief, and any other remedies of any kind (including based on provisional rights) for past, current, and future infringement, and (ii) rights to collect royalties or other payments under or on account of any of the Assigned Patents; and

(e) all rights to register, prosecute, maintain, record or enforce such right, title and interest in or to the Assigned Patents.

Assignor also hereby authorizes the respective patent office or governmental agency in each jurisdiction to issue any and all patents or certificates of invention that may be granted upon any of the Assigned Patents in the name of Assignee, as the assignee to the entire interest therein.

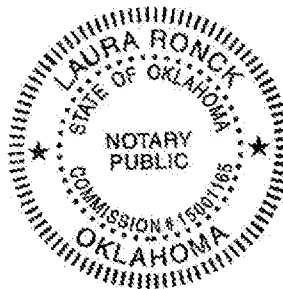


