8. Any and all other rights and interests arising out of, or regarding, or in relation to the RIGHTS.

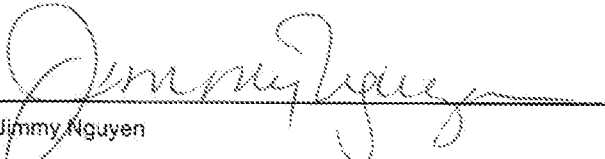
## ASSIGNMENT OF PATENT RIGHTS

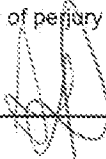

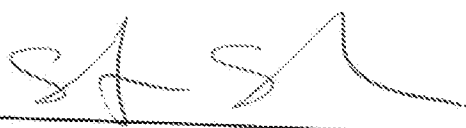
