**SILVER PEAK  
INTELLECTUAL PROPERTY AND TRADEMARKS  
ASSIGNMENT AGREEMENT**

This **SILVER PEAK INTELLECTUAL PROPERTY AND TRADEMARKS ASSIGNMENT AGREEMENT** (the “Agreement”) is being entered into on the 27<sup>th</sup> of October, 2021, by and between:

- (i) **Silver Peak Systems, Inc.**, a corporation organized under the laws of the State of Delaware, United States of America, with its principal place of business at 4500 Great America Parkway, Suite 100, Santa Clara, CA 95054, United States of America (hereinafter “Assignor”); and
- (ii) **Hewlett Packard Enterprise Development LP**, a limited partnership organized under the laws of the State of Texas, United States of America, with a principal office and place of business at 11445 Compaq Center Drive West, Houston, TX 77070, United States of America (hereinafter “Assignee”); and
- (iii) **3Com International, Inc.**, a corporation organized under the laws of the State of Delaware, United States of America, with a principal office and place of business at 11445 Compaq Center Drive West, Houston, TX 77070, United States of America (“3Com”); and
- (iv) **Hewlett Packard Enterprise Company**, a corporation organized under the laws of the State of Delaware, United States of America, with a principal office and place of business at 11445 Compaq Center Drive West, Houston, TX 77070, United States of America (“HPE”).

Assignor, Assignee, 3Com, and HPE are each a “Party” and collectively the “Parties”.

**RECITALS**

**WHEREAS**, Assignor, Assignee, 3Com, USY1 (as defined below), and USZ1 (as defined below) are Affiliates (as defined below) of HPE.

**WHEREAS**, 3Com owns all of the issued and outstanding shares of the capital stock of Assignor; and, HPE owns (i) all of the issued and outstanding shares of the capital stock of 3Com and (ii) all of the issued and outstanding member interests in Enterprise CIT LLC, a limited liability company organized under the laws of the State of Delaware, United States of America, (“USY1”), and Enterprise DC Holdings LLC, a limited liability company organized under the laws of the State of Delaware, United States of America (“USZ1”), each classified as a disregarded entity of HPE for United States federal income tax purposes.

**WHEREAS**, USY1 and USZ1 are partners in Assignee and own, respectively, a 99 percent interest and a 1 percent interest in Assignee, classified as a disregarded entity of HPE for United States federal income tax purposes.

**WHEREAS**, Assignor is the owner of all rights, title, and interest in and to the Silver Peak Intellectual Property and the Silver Peak Trademarks (each term as defined herein).

**WHEREAS**, as described more fully in that certain Silver Peak Integration Plan, as amended from time to time (the “Silver Peak Plan”), and that certain Plan of Liquidation (a copy of which is attached hereto as Exhibit B), effective the 26<sup>th</sup> of October, 2021, among the Parties (the “Plan of

Liquidation”), HPE and its subsidiaries shall enter into various transactions as referred to in the Silver Peak Plan and the Plan of Liquidation.

**WHEREAS**, in furtherance of the Silver Peak Plan and the Plan of Liquidation, 3Com intends to direct Assignor to and, in line with this direction, Assignor intends to assign and transfer to Assignee all of its rights, title, and interest in and to the Silver Peak Intellectual Property and the Silver Peak Trademarks, in exchange for USD 372,174,000.

**WHEREAS**, the Parties intend and agree that the assignments and transfers to Assignee described herein shall be effective, as far as the transfer of legal title is concerned, as of the date of this Agreement (provided, however, that the assignment and transfer of the beneficial and economic ownership, including all economic rights, benefits and burdens, related thereto, shall be effective as of the 1st of November, 2020), but prior to the conversion of Assignor from a corporation into a Delaware limited liability company, followed by a distribution of 3Com’s membership interest in Assignor to HPE and a subsequent distribution of Assignor’s remaining assets to HPE, followed by Assignor’s merger into HPE.

**NOW, THEREFORE:** In consideration of the foregoing and the mutual covenants and agreements set forth below, and other good and valuable consideration, the receipt and adequacy of which is hereby acknowledged, the Parties hereby agree as follows:

## **Section 1 - Definitions**

1.1 “Affiliate” means any company or other business entity that directly or indirectly owns, controls, is controlled by, is under common control with, or becomes in control of, under common control with, or controlled by HPE. In the case of a corporation, ownership or control shall exist through the direct or indirect ownership of more than fifty percent (50%) of the equity or more than fifty percent (50%) of the rights entitling the holders to vote for the election of directors or persons performing similar functions who have a majority vote. In the case of a business entity other than a corporation, ownership or control shall exist through the direct or indirect ownership of more than fifty percent (50%) of the equity or interest in profits of such business entity. However, in any country where the applicable law does not permit foreign equity participation of more than fifty percent (50%), then an Affiliate shall include any company or business entity in which HPE owns or controls, directly or indirectly, the maximum percentage of such outstanding stock or voting rights permitted by applicable law provided HPE exercises actual control over the Affiliate’s operations.

1.2 “Silver Peak Intellectual Property” means the Intellectual Property (as defined herein) owned by Assignor or which Assignor is authorized to sublicense, without being required to provide notification or payment to a third party.

1.3 “Silver Peak Trademarks” means all trademarks, service marks, designs, logos, trade dress, company names, and other source identifiers owned by Assignor, including the marks identified in the attached Schedule A, and all applications and registrations thereof.

1.4 “Intellectual Property” means any and all of the following, anywhere in the world: (a) patents, inventions or utility models, (b) copyrights, rights in writings, other works of authorship, or mask work rights, (c) trade secrets and similar rights in confidential information, and (d) corresponding intellectual and industrial property rights in any jurisdiction, (e) know-how, (f) marketing intangibles, and (g) applications and registrations of any of the foregoing, but Intellectual Property under this Agreement does not include Trademarks.

## **Section 2 - Assignment**

2.1 Silver Peak Intellectual Property. 3Com hereby directs Assignor to and, in line with this direction, Assignor hereby assigns and transfers, and Assignee hereby acquires and accepts from

Assignor, all of Assignor's rights, title, and interests, throughout the world, in and to all the Silver Peak Intellectual Property, provided, however, the assignment and transfer of the beneficial and economic ownership, including all economic rights, benefits and burdens, in and to such Silver Peak Intellectual Property shall be effective as of the 1st of November, 2020, and the assignment and transfer of legal title in and to the same shall be effective as of the date of this Agreement.

2.2 Silver Peak Trademarks. 3Com hereby directs Assignor to and, in line with this direction, Assignor hereby assigns and transfers, and Assignee hereby acquires and accepts from Assignor, all of Assignor's rights, title, and interests, throughout the world in and to the following:

- (a) the Silver Peak Trademarks, including all registrations and applications thereof, all registrations which may be granted in respect of such applications, all renewals of such registrations, and all common law rights therein;
- (b) the trademark goodwill of the business symbolized by such Silver Peak Trademarks;
- (c) the right to bring suit and recover damages for past, present, and future infringement, dilution, misappropriation, violation, or unlawful imitation of such Silver Peak Trademarks;
- (d) the entire right, title, and interest in all convention and treaty rights of all kinds, including without limitation all rights of priority in any country of the world, in and to the above Silver Peak Trademarks; and
- (e) all prosecution history files for such Silver Peak Trademark registrations and applications for trademark registration in the possession of Assignor, as well as records, prototypes, specimens, and materials contained in such files,

provided, however, the assignment and transfer of the beneficial and economic ownership, including all economic rights, benefits and burdens, in and to such Silver Peak Trademarks and items described in (a) through (e) above shall be effective as of the 1st of November, 2020, and the assignment and transfer of legal title in and to the same shall be effective as of the date of this Agreement.

Contemporaneous with this Agreement, Assignor and Assignee may enter into a separate trademark assignment agreement regarding the direct transfer of title and ownership of the Silver Peak Trademarks, together with the trademark goodwill of the business symbolized by such Silver Peak Trademarks, to Assignee, pursuant to which Assignor shall authorize and request the competent authorities to record such agreement and to grant and issue any and all registrations of the Silver Peak Trademarks throughout the world to Assignee, its successors, or assigns.

2.3 In consideration for the assignment and transfer of Assignor's rights, title, and interests in and to the Silver Peak Intellectual Property and the Silver Peak Trademarks, Assignee shall pay to Assignor USD 372,174,000.

### **Section 3 - General Provisions**

3.1 Further Assurances. The Parties will each perform such acts, execute and deliver such instruments and documents, and do all such other things as may be reasonably necessary to accomplish the transactions contemplated in this Agreement.

3.2 Governing Law. The laws of the State of Delaware, U.S.A. (without reference to its principles of conflicts of law) govern the construction, interpretation and other matters arising out of or in connection with this Agreement (whether arising in contract, tort, equity or otherwise).

3.3 Severability. If any provision of this Agreement is determined to be invalid, illegal or unenforceable, the remaining provisions of this Agreement shall remain in full force, if the essential terms and conditions of this Agreement for each Party remain valid, binding and enforceable.

3.4 No Waiver. The failure by either Party to assert any of its rights hereunder, including, but not limited to, the right to terminate this Agreement due to a breach or default by the other Party, shall not be deemed to constitute a waiver by that Party of its right thereafter to enforce each and every provision of this Agreement in accordance with its terms.

3.5 Entire Agreement. This Agreement constitutes the final agreement between the Parties with respect to the subject matter contained herein, and is the complete and exclusive statement of the Parties' agreement on the matters contained herein. All prior and contemporaneous negotiations and agreements between the Parties with respect to the matters contained herein are superseded by this Agreement.

3.6 Amendment. The Parties may amend this Agreement only by a written agreement signed by each Party to be bound by the amendment and that identifies itself as an amendment to this Agreement.

3.7 Counterparts. The Parties may execute this Agreement in multiple counterparts, each of which constitutes an original instrument, and all of which together constitute one agreement. The signatures of all the Parties need not appear on the same counterpart. The delivery of signed counterparts by facsimile or email transmission that includes a copy of the sending Party's signature is as effective as signing and delivering the counterpart in person. Execution by electronic signature, such as through use of DocuSign or other similar software, or a facsimile or .pdf of a signature shall be considered equivalent to an original, "wet" signature. The Parties agree not to contest the validity, enforceability and authenticity of an electronic document or electronic signature on the basis that it has been originated, executed and stored in an electronic rather than a physical form.

3.8 Successors and Assigns; Assignment. This Agreement shall be binding on and inure to the benefit of the Parties, their successors in interest and assigns. No Party may assign any of its rights nor delegate any of its obligations under this Agreement without the written consent of the other Parties, which consent may be withheld in its sole and absolute discretion and any assignment or attempted assignment in violation of the foregoing will be null and void.

3.9 Authority. Each of the Parties represents to the other that (a) it has the corporate or other requisite power and authority to execute, deliver and perform this Agreement, (b) the execution, delivery and performance of this Agreement has been duly authorized by all necessary corporate or other action, (c) it has duly and validly executed and delivered this Agreement, and (d) this Agreement is a legal, valid and binding obligation, enforceable against it in accordance with its terms, subject to applicable bankruptcy, insolvency, reorganization, moratorium or other similar laws affecting creditors' rights generally and general equity principles.
