**WHEREAS**, Assignee desires to acquire the entire right, title, and interest in the Patent Rights, any related applications, and inventions related thereto, from Assignor.

**NOW, THEREFORE**, be it known that for good and valuable consideration as set forth in the APA, the receipt and sufficiency of which are hereby acknowledged, Assignor by these presents does hereby sell, assign, transfer, and convey to Assignee, its successors, assigns, and legal representatives, the entire right, title, and interest in and to the Patent Rights, any related patent applications, and inventions related thereto, and in any improvements on the Patent Rights previously or in the future made or acquired by Assignor, and to all rights of priority to the same pursuant to the International Convention for the Protection of Industrial Property, and in and to any and all continuations, continuations-in-part, or divisionals of any patent application filed on the Patent Rights, and in and to any and all Letters Patent of all countries or reissues thereof which may be granted therefor or thereon, for the full end of the term or terms for which said Letters Patent are or may be granted, or reissued, the same to be held and enjoyed by said Assignee, its successors and assigns, as fully and entirely as the same would have been held and

enjoyed by Assignor if this Assignment and sale had not been made, together with all claims for damages by reason of past infringement of the Patent Rights or Letters Patent, with the right to sue for and collect the same for Assignee's own use, and for the use of Assignee's successors, assigns, or other legal representatives.

Assignor further warrants and represents that, at the time of the execution and delivery of the APA and Written Notice, Assignor possessed full title to the Patent Rights, any related applications, and inventions related thereto, and that it had the unencumbered right and authority to make this Assignment.


