ASSIGNMENT

- any application filed in any country, jurisdiction or other authority based thereon, including direct or indirect nonprovisional, divisional, continuation-in-part or substitute applications, and including the right to file said applications under the provisions of the Paris Convention for the Protection of Industrial Property, the Patent Cooperation Treaty or other international convention or agreement;
- any and all patents or reissues or extensions thereof to be obtained in any country, jurisdiction or other authority which may be filed upon said invention or inventions in any country or other authority;
- all such rights relating to prior infringements, retroactive or past royalties, provisional rights, and other retroactive or past relief or compensation.

The Assignor hereby authorizes and requests the issuing authority to issue any and all patents on said application or applications to Assignee or its successors and assigns as a partial owner.

The Assignor further agrees, to execute and deliver to Assignee, its representatives or agents or its successors and assigns, on request, all lawful papers required to make any of the foregoing provisions effective to obtain and enforce proper patent protection for said invention or inventions in any country.
