DEED OF ASSIGNMENT

THIS ASSIGNMENT is made this 13th day of Sept. 2021 between

DEBEN GROUP INDUSTRIES LIMITED, a company incorporated in England and Wales, registration number 02813799, of Avocet House, Wilford Bridge Road, Melton, Woodbridge, Suffolk, IP12 1RB (**hereinafter called the Assignor**)

and

HAWKE OPTICS LIMITED, a company incorporated in England and Wales, registration number 08448192, of Avocet House, Wilford Bridge Road, Melton, Woodbridge, Suffolk, IP12 1RB (**hereinafter called the Assignee**).

WHEREAS the Assignor is registered as proprietor of the pending and granted Patents identified in the Schedule below (**hereinafter called the Patents**) for the Inventions described in the Patents (**hereinafter called the Inventions**).

AND WHEREAS by an agreement dated 3 November 2020 the Assignor and the Assignee agree, inter alia, that the Assignor would assign to the Assignee all of its right, title and interest in and to the Patents.

NOW THIS ASSIGNMENT WITNESSETH AS FOLLOWS:

1 In consideration of the sum of £1 (one pound sterling) paid to the Assignor by the Assignee, the receipt of which is hereby acknowledged, the Assignor HEREBY ASSIGNS to the Assignee with full title guarantee:

1.1 all of the Assignor's right, title and interest in and to the Inventions and the full and exclusive benefit of the Inventions in all the countries of the world;

1.2 all of the rights of the Assignor to and in the Patents and the right in respect of the Patents to claim priority from the Patents under the Paris Convention and to apply to each of the national and international Patent Offices to be registered as proprietor of the Patents; and

1.3 all causes of action which may have accrued to the Assignor anywhere in the world in relation to any infringement of any of the rights hereby assigned

TO HOLD the same unto and to the use of the Assignee, its successors and assigns absolutely.

2 The Assignor HEREBY COVENANTS with the Assignee that the Assignor will at the expense of the Assignee execute sign and do all such instruments applications documents acts and things as may reasonably be required by the Assignee to enable the Assignee (or the nominee of the Assignee) to enjoy the full benefit of the property and rights hereby assigned.

3 The amount stated in this agreement to be payable by the Assignee to the Assignor is exclusive of value added tax ("VAT") which shall be payable by the Assignee and the Assignor shall deliver to the Assignee upon request a proper VAT invoice for the amount (if any) of VAT chargeable.

4 This Assignment shall be construed in accordance with and governed by English law and the English courts shall have jurisdiction over any disputes thereunder.

5 Unless expressly provided in this Agreement, no term of this Agreement is enforceable pursuant to the Contracts (Rights of Third Parties) Act 1999 by any person who is not a party to it.




