**GRANT OF SECURITY INTEREST

This Grant has been given in conjunction with the security interest granted to the Collateral Agent under the Security Agreement, and the provisions of this Grant are without prejudice to and in addition to the provisions of the Security Agreement, which are incorporated herein by this reference, including, for the avoidance of doubt, Section 8.8 of the Security Agreement.
