do all lawful acts and to execute and deliver, without further consideration other than expenses reasonably incurred, all further documents as may reasonably be required by the Assignee, or by its successors, assigns, nominees, or other legal representatives, to obtain patents in Canada and the United States and all other countries and jurisdictions for the Invention and vest or secure the same in the Assignee, and in the Assignee's successors, assigns, nominees or other legal representatives; and grants to said Assignee, its successors, assigns, nominees or other legal representatives, including its patent agents and attorneys, the power to insert on this assignment any further information which may be necessary or desirable in order to place this document in compliance for recordation.

THIS UNIVERSAL ASSIGNMENT OF INVENTION may be executed in counterparts, all of which shall be considered one and the same agreement.


