its own use and behalf and the use and behalf of its successors, legal representatives, and assigns, to the full end of the term or terms for which patents may be granted as fully and entirely as the same would have been held and enjoyed by the ASSIGNOR had this sale and assignment not been made;

And ASSIGNOR hereby covenants and agrees that ASSIGNOR has the full right to convey the entire interest herein assigned, and that ASSIGNOR has not executed, and will not execute, any agreement in conflict herewith;

And ASSIGNOR hereby further covenants and agrees that ASSIGNOR will communicate to the ASSIGNEE, its successors, legal representatives and assigns, any facts known to it respecting said INVENTION, testify in any legal proceeding, sign all lawful papers, execute all divisional, continuing, reissue and foreign applications, make all rightful oaths, and generally do everything possible to aid the ASSIGNEE or, its successors, legal representatives and assigns, to obtain and enforce proper protection for said INVENTION in all countries;

And ASSIGNOR hereby authorizes the ASSIGNEE's patent attorney to complete this form and/or append a listing hereto with the addition of the application number, application filing date, and attorney docket number for any and all such applications to which this assignment applies.
