CONFIRMATORY IP ASSIGNMENT

This CONFIRMATORY IP ASSIGNMENT ("Assignment") is by and between TOUCHCODE HOLDINGS, LLC, a limited liability corporation organized under the laws of the State of Delaware, with its principal office at 119 West 57th Street, Suite 1015, New York, New York 10019, United States of America ("Assignor"), and, E2IP TECHNOLOGIES INC. a company incorporated under the laws of Québec, Canada and having its principal office at 750 Marcel-Laurin, Suite 375, Québec, Canada, H4M 2M4 ("Assignee").

A. WHEREAS, Assignor and Assignee are parties to a Patent Assignment Agreement dated August 18, 2021 (the "Agreement"), regarding the Assignee's purchase of the Acquired Patents;

B. WHEREAS, pursuant to the terms of the Agreement, Assignor assigned to Assignee rights to the Acquired Patents; and

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties hereto have agreed and continue to agree as follows:

1. Conveyance. Assignor confirms that Assignor has assigned, and if any rights remain not transferred pursuant to the Agreement, does hereby sell, convey, assign and transfer to Assignee, without reservation, all of Assignor's right, title and interest in and to the Acquired Patents pursuant to the terms of the Agreement, and (ii) all benefits, privileges, causes of action, common law rights, and remedies relating thereto, including, without limitation, all of Assignor's rights to: (a) claim priority from, apply for and maintain all registrations, renewals and/or extensions thereof, (b) bring actions and recover damages for past, present and future infringement or other violation thereof and (c) grant licenses or other interests therein.

2. "Acquired Patents" means: those patents set forth and described on Schedule A attached hereto.

3. Recordation. Assignor authorizes and requests the United States Commissioner of Patents and Trademarks and any other similar government authority, domestic or in any foreign country, to record Assignee as owner of the Acquired Patents as assignee of the entire right, title and interest in, to and under the same, for the sole use and enjoyment of Assignee and its successors, assigns or other legal representatives. Assignee shall have the right to record this Assignment with all applicable government authorities and registrars, domestic or in any foreign country, so as to perfect its ownership of the Acquired Patents.

4. Counterparts. This Assignment may be executed in one or more counterparts, and by the different parties hereto in separate counterparts, each of which when executed will be deemed to be an original but all of which taken together will constitute one and the same agreement. Delivery of an executed counterpart of a signature

page to this Assignment by telecopy or by electronic delivery in Adobe Portable Document Format will be effective as delivery of a manually executed counterpart of this Assignment.






