## TERMINATION AND RELEASE OF SECURITY INTEREST IN PATENTS

This **TERMINATION AND RELEASE OF SECURITY INTEREST IN PATENTS** (this “*Termination and Release*”) is granted as of February 24, 2022 by **M&T BANK** (the “*Grantee*”), in favor of **MEDI-SOLVE COATINGS, LLC**, a Massachusetts limited liability company and **SANFORD PROCESS CORPORATION**, a Delaware corporation and (each a “*Grantor*” and collectively, the “*Grantors*”).

**WHEREAS**, the Grantors executed and delivered a Grant of Security Interest in United States Patents dated as of October 3, 2019 (as amended, restated, supplemented or otherwise modified prior to the date hereof, the “*Grant*”; all capitalized terms used but not defined herein shall have the meaning set forth in the Grant), granting the Grantee a security interest in and lien on certain patents and patent applications (“*Patents*”) described therein, which was recorded with the United States Patent and Trademark Office (“*USPTO*”) on October 21, 2019, at Reel 050774, Frame 0479;

**WHEREAS**, the Grantors have requested that the Grantee hereby terminate, release and discharge fully its security interests in and liens on all right, title and interest of the Grantors in, to and under all of the Patents as herein provided; and

**WHEREAS**, the Grantors have requested that the Grantee provide a document suitable for recording in the United States Patent and Trademark Office to evidence the release of its security interests in and liens on the Patents as herein provided.

**NOW, THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Grantee hereby:

1. terminates the Grant and releases, terminates and discharges all liens and security interests in the Grantors’ right, title and interest in, to and under the (i) Patents, including those Patents identified in Schedule A hereto; (ii) all proceeds and products of the Patents; and (iii) all causes of action arising prior to or after the date hereof for infringement of any of the Patents; and assigns, transfers and conveys to Grantors any interest in all of the foregoing, including any lien and security interest thereof; and
2. authorizes and requests that this Termination and Release be recorded at the USPTO.
