## RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY

This Release of Security Interest in Intellectual Property is made as of February 16, 2022, by CANADIAN IMPERIAL BANK OF COMMERCE (as successor in interest to WF Fund V Limited Partnership, under an Assignment and Assumption Agreement dated as of January 5, 2018 and recorded with the U.S. Patent and Trademark Office (i) with respect to patents on January 9, 2018 at Reel/Frame 045028/0880 and (ii) with respect to trademarks on January 9, 2018 at Reel/Frame 6245/0274, "**Lender**") in favor of TIGERCONNECT, INC., a Delaware corporation (formerly known as TIGERTEXT, INC.) ("**Grantor**") with its principal place of business located at 2110 Broadway, Santa Monica, CA 90404.

### Recital

WHEREAS, Grantor granted to Lender a security interest in all of Grantor's right, title and interest in its Intellectual Property, including the copyrights, patents and trademarks described on Exhibits A, B and C attached hereto under an Intellectual Property Security Agreement dated as of April 12, 2017, as amended from time to time (the "**IP Security Agreement**") and recorded with Library of Congress Copyright Office June 17, 2020 at V9979 D160 P1-4 and at the U.S. Patent and Trademark Office (i) with respect to patents on April 21, 2021 at Reel/Frame 055995/0776, on June 24, 2019 at Reel/Frame 049570/0804 and on April 12, 2017 at Reel/Frame 041987/0885 and (ii) with respect to trademarks on April 21, 2021 at Reel/Frame 7266/0542, on June 24, 2019 at Reel/Frame 6676/0910 and on April 12, 2017 at Reel/Frame 6033/0271.

WHEREAS, Grantor has requested and Lender has agreed to release its security interest in the Intellectual Property, including without limitation the copyrights, patents and trademarks described on Exhibits A, B and C, and terminate the IP Security Agreement.

### Agreement

Now, therefore, for good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, Lender hereby terminates and releases its security interest in the Intellectual Property (including without limitation the copyrights, patents and trademarks described on Exhibits A, B and C), terminates the IP Security Agreement and all resulting rights, and reassigns to Grantor all right, title, and interest of Lender in or to the Intellectual Property.


