AND ASSIGNOR HEREBY authorizes the Commissioner of Patents and Trademarks at the United States Patent and Trademark Office, its territorial possessions and any other governmental authority of any and all foreign countries to record Assignee as the owner of the Assigned Patents and to issue all patents for the invention directly to ASSIGNEE, it's successors, legal representatives and assigns;
