CONFIRMATORY DEED OF ASSIGNMENT

THIS CONFIRMATORY DEED OF ASSIGNMENT has an effective date of 26 August 2020.

PARTIES:

The Assignor: BATTERY RESEARCH TECHNOLOGY LIMITED of 20th Floor, Wah Hing Commercial Building, 283 Lockhart Road, Wan Chai, Hong Kong.

The Assignee: CLEANCELL AG of Seestrasse 1, 6330 Cham, Switzerland.

Who together are referred to as the "Parties".

WHEREAS:

 - 2.2. the full right to file the intellectual property applications and registrations and to apply for and obtain further intellectual property applications and registrations or other similar forms of protection in respect of that as listed in ANNEXURE A throughout the world, including without limitation, the types of applications listed in ANNEXURE B; and
 - 2.3. the right to claim priority from any one of the intellectual property applications listed in ANNEXURE A under the Paris Convention or under World Trade Organisation agreements, Patent Cooperation Treaty (PCT) when making applications in Paris Convention countries or territories, or when making applications in non-Paris Convention Countries, or national phase entries from any PCT patent applications.
- 3. The Assignor confirms that it agreed to execute, sign and do all such instruments, applications, documents, acts and things as shall be necessary for assuring and registering the Assignee's title to the intellectual property applications and

registrations and for evidencing the assignment of the rights hereunder to the Assignee.

4. The Parties hereby agree that this Assignment shall be governed by the laws of Hong Kong and submit to the non-exclusive jurisdiction of the Courts of Hong Kong.


