

Inventor (including any and every heir, executor and administrator of the Inventor) agrees (a) to execute and deliver to Assignee (or any affiliates) without further consideration any applications, agreements or other materials; (b) to cooperate with Assignee in the procurement, maintenance and enforcement of rights relating to the Inventions/Patent Rights; and (c) to perform on behalf of Assignee any lawful acts that may be deemed necessary or appropriate by Assignee to obtain, maintain and enforce the rights of Assignee in the Inventions/Patent Rights.
