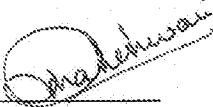
WHEREAS, Assignee wishes to obtain all of Assignors rights, title and interest in and to the assigned Patents.

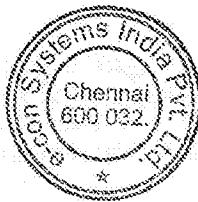

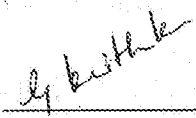

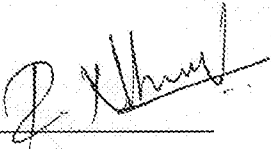
