
JSB PHARMA DEVELOPMENT BILL OF SALE AND INSTRUMENT OF ASSIGNMENT AND ASSUMPTION

WHEREAS, Transferor conducts a business of the invention, research, development and commercialization of certain products and compounds (the "Compounds Business");





If at any time, Transferee shall reasonably consider it advisable that any further conveyance, agreements, documents, instruments and assurances of law or any other things are necessary or appropriate to vest, perfect, confirm or record in Transferee the title to any of the Transferred Assets, Transferor shall execute and deliver, upon Transferee's request and at Transferee's cost but for no additional consideration, any and all proper conveyances, agreements, documents, instruments and assurances of law, and do all things reasonably necessary or proper to vest, perfect, confirm or record title to the Transferred Assets and the Compounds Business in Transferee and otherwise to carry out the provisions of this Instrument.

The provisions of this Instrument shall be binding upon and inure to the benefit of the parties hereto and their respective successors and permitted assigns; <u>provided that</u> no transfer or assignment will relieve the transferring or assigning party of its obligations under this Instrument.

This Instrument shall be construed in accordance with and governed by the law of the State of Delaware, without giving effect to the conflicts of law rules thereof that would result in the application of the laws of any other jurisdiction. Each party hereto agrees that it shall bring any action between the parties hereto arising out of or related to this Agreement exclusively in the United States District Court for the District of Delaware and the appellate courts having jurisdiction of appeals in such courts or, to the extent such federal courts do not have subject matter jurisdiction, the Superior Court of the State of

Delaware (collectively, the "<u>Chosen Courts</u>"), and, solely with respect to any such action (i) irrevocably submits to the exclusive jurisdiction of the Chosen Courts, (ii) waives any objection to laying venue in any such action in the Chosen Courts, and (iii) waives any objection that the Chosen Courts are an inconvenient forum or do not have jurisdiction over any party hereto.

EACH OF THE PARTIES HERETO HEREBY IRREVOCABLY WAIVES, TO THE FULLEST EXTENT PERMITTED BY LAW, ANY RIGHT TO TRIAL BY JURY OF ANY ACTION, SUIT OR PROCEEDING ARISING UNDER THIS AGREEMENT OR IN ANY WAY CONNECTED WITH OR RELATED OR INCIDENTAL TO THE DEALINGS OF THE PARTIES HERETO IN RESPECT OF THIS AGREEMENT, IN EACH CASE WHETHER NOW EXISTING OR HEREAFTER ARISING, AND WHETHER IN CONTRACT, TORT, EQUITY OR OTHERWISE (INCLUDING, FOR THE AVOIDANCE OF DOUBT, ANY SEEKING EQUITABLE RELIEF).

This Instrument may be executed in one or more counterparts, all of which shall constitute one and the same instrument. Any such counterpart, to the extent delivered by means of a facsimile machine or by .pdf, .tif, .gif, .jpeg or similar attachment to electronic mail (any such delivery, an "Electronic Delivery") shall be treated in all manner and respects as an original executed counterpart and shall be considered to have the same binding legal effect as if it were the original signed version thereof delivered in person.

No failure or delay by either party in exercising any right, power or privilege hereunder shall operate as a waiver thereof nor shall any single or partial exercise thereof preclude any other or further exercise thereof or the exercise of any other right, power or privilege.
