I, SAID ASSIGNOR, hereby further covenants and agrees that the ASSIGNEE may apply for foreign Letters Patent on the invention and claim the benefits of the International Convention, and that I/we will, at any time, when called upon to do so by the ASSIGNEE, communicate to the ASSIGNEE as the case may be, any facts known to me respecting the invention, and execute and deliver any and all lawful papers that may be necessary or desirable to perfect the title to the invention, the applications, and the Letters Patent in the ASSIGNEE, and that if reissues or
