PATENT APPLICATION ASSIGNMENT AGREEMENT

NOW THEREFORE, in consideration of the mutual promises, covenants, warranties, and other good and valuable consideration set forth herein, and in accordance with applicable law, the Parties hereby agree as follows:

1. *Assignment.* Assignor hereby assigns to Assignee, and its successors, representatives, and assigns, all right, title, and interest in the aforementioned patent applications including all reexaminations, extensions, and reissues thereof. Assignor hereby requests the Commissioner of Patents of the United States to record this assignment of all right, title, and interest in the aforementioned patents to Assignee.

2. *Assignor's Representations and Warranties.* Assignor hereby represents and warrants

i) that it has the legal right and authority to execute this Agreement, and to validly assign the entire interest in the aforementioned patents to Assignee,

ii) that it has not executed any other agreement that would conflict with the terms of this Agreement, nor shall it execute any such agreement in the future, and

iii) that to the best of Assignor's knowledge, the aforementioned patents are valid and enforceable as of the date of this Agreement. Assignor makes no representations or warranties as to the validity or enforceability of the aforementioned patents subsequent to the date of this Agreement.

3. *Patent Status.* Assignee hereby acknowledges that any finding or ruling subsequent to the date of this Agreement that any of the aforementioned patents are invalid or unenforceable shall not give rise to a cause of action against Assignor under this Agreement.

4. *Headings.* The headings for section herein are for convenience only and shall not affect the meaning of the provisions of this Agreement.
