PATENT ASSIGNMENT

NOW THEREFORE, pursuant to the premises set forth above and in the Purchase Agreement and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged:

1. Assignment of Rights. Assignor hereby assigns to Assignee, and Assignee hereby accepts, all of Assignor's rights, titles and interests in and to the Assigned Patents and any and all patents from which any and all Assigned Patents claim priority, including without limitation (a) any and all legal actions and rights and remedies at law or in equity for past, present, or future infringements, misappropriations, or other violations of the Assigned Patents and the right to sue for, collect, and retain all past, present and future damages, profits, proceeds, and all other remedies associated therewith and (b) all priority rights arising from the Assigned Patents, including the right to claim priority in the any international conventions and any other jurisdictions, and (c) any and all applications from which any and all Assigned Patents claim priority.

2. Recordation. Assignor hereby authorizes and requests the United States Patent and Trademark Office and any similar Governmental Authority to record this Patent Assignment and Assignor agrees that Assignee shall have the right to record Assignee's rights in the Assigned Patents, in its name, in the United States Patent and Trademark Office or any similar Governmental Authority.

3. Counterparts. This Patent Assignment may be executed electronically or otherwise (where permitted in an applicable jurisdiction) in any number of identical counterparts each of which when so executed shall be deemed to be an original and all of which taken together shall constitute one and the same agreement.

4. Relation to Purchase Agreement. Assignor and Assignee hereby acknowledge and agree that this Patent Assignment is executed and delivered pursuant to, and is in accordance with, the Purchase Agreement. In the event that any provision of this Patent Assignment shall be construed to conflict with a provision in the Purchase Agreement, the provision in the Purchase Agreement shall control.
