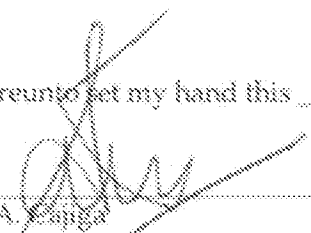

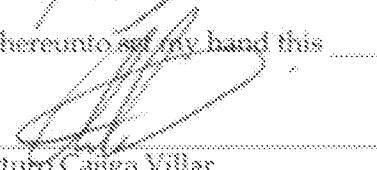
And we also hereby covenant and agree to sign all proper papers including other

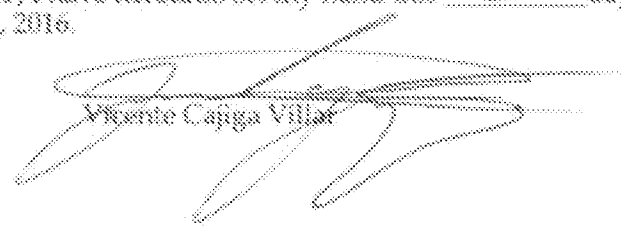
