ASSIGNOR hereby grants the cognizant attorney of record the power to insert on this Assignment (and/or on any ancillary document) any further identification that may be necessary or desirable in order to comply with the rules of the United States Patent and Trademark Office for recordation of this document;

In the event that **ASSIGNEE** is unable, after reasonable effort, to secure **ASSIGNOR**'s signature on any paper or other instrument relating to **INVENTIONS** in any country, whether because of **ASSIGNOR**'s mental incapacity, death, or for any other reason whatsoever, **ASSIGNOR** hereby irrevocably designates and appoints **ASSIGNEE** and its duly authorized officers and agents as **ASSIGNOR**'s agent and attorney in fact to act for and to execute, file, and prosecute **APPLICATIONS** within said listed **INVENTIONS**, any such related applications, paper, or other instrument on **ASSIGNOR**'s

behalf, and to do all other lawfully permitted acts to further the prosecution and issuance of any patent application related to INVENTIONS, with the same legal force and effect as if executed by ASSIGNOR;

ASSIGNOR hereby covenants that no assignment, sale, agreement, or encumbrance has been or will be made or entered into which would conflict with this sale, assignment, and transfer; and that ASSIGNOR has the rights, titles, and interests to convey as set forth herein; AND

ASSIGNOR further covenants that upon ASSIGNEE's request, ASSIGNOR will provide promptly to ASSIGNEE all pertinent facts and documents relating to APPLICATIONS and/or any such related application, as may be known and accessible to ASSIGNOR; that ASSIGNOR will testify as to the same in any interference or litigation related thereto; and that ASSIGNOR will promptly execute and deliver to ASSIGNEE or its legal representatives and/or successor, without further consideration, any and all papers, instruments, or affidavits required to apply for, prosecute, obtain, maintain, and enforce any patents issuing from APPLICATIONS and any related patent application, as may be deemed necessary or desirable by ASSIGNEE to carry out the purposes of this Assignment.
