TERMINATION AND RELEASE OF PATENT SECURITY AGREEMENT

THIS TERMINATION AND RELEASE OF PATENT SECURITY AGREEMENT (this "Termination"), is dated as of February 18, 2022, and made by **PNC BANK, NATIONAL ASSOCIATION** (together with its successors and assigns in such capacity, the "Collateral Agent"), to **SMARSH INC.**, a New York corporation, **MOBILEGUARD, LLC**, a Delaware limited liability company, f/k/a **MOBILEGUARD INC.**, a Nevada corporation, **ACTIANCE, INC.**, a Delaware corporation, **ACTIANCE HOLDINGS, INC.**, a Delaware corporation, and **SKYWALKER INTERMEDIATE HOLDINGS, INC.**, a Delaware corporation (each a "Grantor" and collectively, the "Grantors").

WHEREAS, pursuant to that certain Patent Security Agreement dated as of February 27, 2018, made by Grantors in favor of the Collateral Agent (the "Security Agreement"), a security interest was granted by the Grantors to the Collateral Agent in certain collateral, including the Patent Collateral;

WHEREAS, the Security Agreement was recorded with the patent division of the United States Patent and Trademark Office on February 28, 2018, at Reel/Frame 045065/0916;

WHEREAS, the Collateral Agent now desires to terminate the Security Agreement and terminate, release and discharge its security interest in the Patent Collateral;

NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, and upon the terms set forth in this Termination, the Collateral Agent hereby states as follows:

1. Definitions. Capitalized terms used but not defined herein shall have the same meanings assigned to such terms in the Security Agreement.

2. Release of Security Interest. the Collateral Agent hereby terminates the Security Agreement and terminates, releases and discharges its security interest in all of the Grantors' right, title and interest of every kind and nature in the Patent Collateral, including those Patents and Licenses referred to on Exhibit A hereto and reassigns to the person or persons legally entitled thereto all right, title and interest of the Collateral Agent (if any), in, to and under the Patent Collateral.


