ReForm Biologics, Inc., a corporation organized and existing under and by virtue of the General Corporation Law of the State of Delaware (the “**Corporation**”),

DOES HEREBY CERTIFY:

1. That the Board of Directors of the Corporation have duly adopted resolutions proposing and declaring advisable that the Amended and Restated Certificate of Incorporation of the Corporation, as amended (the “**Certificate of Incorporation**”), be further amended as follows:

RESOLVED: That the Board of Directors recommends and deems it advisable and in the best interests of the Corporation that the Amended and Restated Certificate of Incorporation of the Corporation, as amended, be further amended by deleting Article FIRST thereof in its entirety and substituting for said Article FIRST a new Article FIRST (the “**Charter Amendment**”), as follows:

“**FIRST:** The name of this corporation is Comera Life Sciences, Inc. (the “**Corporation**”).”

RESOLVED: That the officers of the Corporation be, and they hereby are, and each of them acting singly hereby is, authorized and directed to execute, deliver and file a Certificate of Amendment setting forth the Charter Amendment on behalf of the Corporation with the Secretary of State of the State of Delaware, any such officer's approval to be conclusively evidenced by the execution and delivery of such Certificate of Amendment.

2. That this Certificate of Amendment, which amends the provisions of the Certificate of Incorporation, has been duly adopted in accordance with Section 242 of the General Corporation Law.

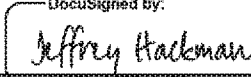
