### CONFIRMATORY DEED OF ASSIGNMENT

THIS CONFIRMATORY DEED OF ASSIGNMENT is effective as of December 30, 2021, by and between Sportswear Company S.p.A. (IN SIGLA SPW S.P.A.), an Italian joint stock company with a principal business address of Galleria Cavour, 4 40124 Bologna Italy (hereinafter "Sportswear Company") and Moncler S.p.A., an Italian joint stock company with a principal business address of Via Stendhal 47, 20144 Milano Italy (hereinafter "Moncler").

WHEREAS, in accordance with an agreement dated December 30, 2021, Sportswear Company assigned, transferred, and sold the Intellectual Property Rights listed in Exhibit A (the "IP Rights") to Moncler, together with the goodwill of the business associated therewith; and

WHEREAS, Sportswear Company and Moncler desire to confirm and record the assignment of the IP Rights, together with the goodwill of the business associated therewith.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged:

1. Sportswear Company declares to have assigned, as proprietors, unto Moncler all rights, title, and interest in and to the IP Rights, together with the goodwill of the business associated therewith; and
2. Moncler confirms to have received all right, title, and interest to the IP Rights and any and all goodwill of the business associated therewith.

Sportswear Company agrees to execute and deliver at the request of Moncler, all papers, instruments and assignments, and to perform any other reasonable act that Moncler may require in order to vest all of Sportswear Company's right, title and interest in and to the IP Rights in Moncler and/or to provide evidence to support any of the foregoing in the event such evidence is deemed necessary by Moncler, to the extent such evidence is in possession or control of Sportswear Company.

This Confirmatory Deed of Assignment may be signed in any number of counterparts, including electronic counterparts, with the same effect as if the signature on each counterpart were on the same instrument.

This Confirmatory Deed of Assignment shall be construed under and governed by the laws of the United States of America, without regard to principles of conflict of laws. This document sets forth the entire agreement and understanding between the parties relating the subject matter hereof.
