- (B) The Assignor has agreed to assign all rights, title, interest and property in the Patents to the Assignee, together with all ancillary rights relating thereto upon the following terms.

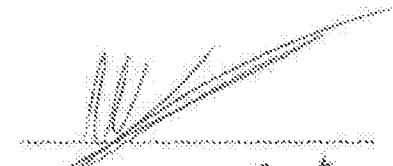
OPERATIVE PROVISIONS

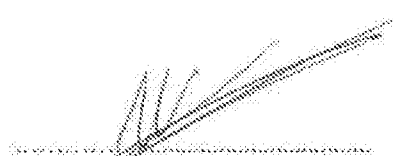
