AND I HEREBY covenant and agree with ASSIGNEE, its successors and assigns, that I have the full right to convey the entire interest assigned herein, and that I have not executed, and will not execute, any agreement in conflict herewith, and that I will not do any other act whatsoever conflicting with these presents, and that I or my successors, assigns, executors, or administrators will at any time upon request, at the expense of ASSIGNEE, its successors and assigns, communicate to ASSIGNEE, its successors and assigns, any facts known to ASSIGNOR respecting said invention, and testify in any legal proceedings, sign any lawful papers, execute any original, divisional, continuation, and continuation-in-part applications, make any rightful oaths or declarations, and generally do such additional acts as ASSIGNEE, its successors and assigns, may deem necessary or desirable to obtain and enforce proper protection for said invention throughout the world;

AND I HEREBY FURTHER covenant and agree that this Assignment is effective as of October 31, 2019.

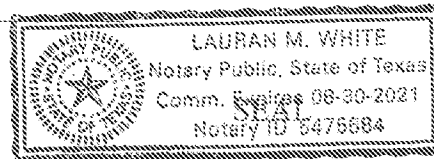
