**RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY**

This **RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY** (the “Release”) is dated as of February 16, 2022 by **OBSIDIAN AGENCY SERVICES, INC.**, a California corporation (“Agent”), for itself and as agent for others in favor of FINANCIALFORCE.COM, INC. (“Borrower”).

**WITNESSETH**

WHEREAS, Agent, various lenders and Borrower entered into that certain Loan and Security Agreement, dated as of January 30, 2019 (as amended, restated, supplemented, or otherwise modified from time to time) (the “Security Agreement”);

WHEREAS, pursuant to the Security Agreement, the Borrower executed and delivered to Agent (a) that certain Intellectual Property Security Agreement dated as of August 29, 2014 (the “IP Security Agreement”) and recorded the same with the United States Patent and Trademark Office (“USPTO”) on February 22, 2019 at Reel/Frame No. 6570-549, pursuant to which the Borrower granted and pledged to Agent for the benefit of the Lenders a security interest in all of its right, title and interest in, to and under the Collateral (as defined in the IP Security Agreement);

WHEREAS, pursuant to the Security Agreement, the Borrower executed and delivered to Agent that certain Amended and Restated Intellectual Property Security Agreement dated as of June 30, 2021 (the “A/RIP Security Agreement”) and recorded the same with the USPTO on July 15, 2021 at Reel/Frame No. 056872/0236, which A/R IP Security Agreement replaced the IP Security Agreement;

WHEREAS, pursuant to the A/R IP Security Agreement the Borrower granted and pledged to Agent for the benefit of the Lenders a security interest in all of its right, title and interest in, to and under the Collateral (as defined in the A/R IP Security Agreement);

WHEREAS, Borrower has paid in full all of the Obligations (as defined in the Security Agreement), and under the terms of the A/R IP Security Agreement, the security interest in all Collateral (as defined in the A/R IP Security Agreement) has automatically terminated; and

WHEREAS, Agent is obligated under the terms of the A/R IP Security Agreement to execute, acknowledge, and deliver to Borrower this Release.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Agent on behalf of itself and the Lenders does hereby (i) terminate the liens and security interest created under the A/R IP Security Agreement in all Collateral (as defined in the A/R IP Security Agreement), (ii) release its security interest in all Collateral (as defined in the A/R IP Security Agreement), and (iii) discharge any and all rights, title and interest it has in and the security interest granted to Agent and/or Lenders in all Collateral (as defined in the A/R IP Security Agreement). For the avoidance of doubt, Agent on behalf of itself and the Lenders hereby authorizes and requests the Commissioner of Patents and Trademarks of the United States to record the release, cancellation and termination of the security interests in the Collateral (as defined in the A/R IP Security Agreement), including such Collateral identified on Schedule I attached hereto.
