AND, ASSIGNOR hereby authorizes and requests the Commissioner of Patents of the United States, its territorial possessions, and any and all foreign countries to issue any and all Letters Patent on said invention, or resulting from said application, and from any and all divisions and continuations, extensions, reissues or reexaminations thereof to the said ASSIGNEE, of the entire interest, and hereby covenant that ASSIGNOR has full right to convey the entire interest therein assigned, and that ASSIGNOR has not executed and will not execute any agreement in conflict therewith.

AND, ASSIGNOR further hereby covenants and agrees that ASSIGNOR will, at any time, upon request, at the expense of said ASSIGNEE, execute and deliver any and all papers that may be necessary or desirable to perfect the title to said Letters Patent as may be granted therefor, in said ASSIGNEE, its successors, assigns, or other legal representatives, and that if said ASSIGNEE, its successors, assigns, or other legal representatives shall desire to file any divisional or continuation application, or to secure an extension, a reissue or certificate of reexamination of

history thereof, as may be known to them, and testify as to the same in any interference or other litigation, when requested to do so.
