Authorizes ASSIGNEE to file patent applications in any or all countries for the Patent Rights in the name of ASSIGNOR, in the name of any previous assignor, who authorized the filing under a similar obligation to ASSIGNOR, or in the name of ASSIGNEE or otherwise as ASSIGNEE may deem advisable, under an International Convention or otherwise;**

**3. Authorizes and requests the Commissioner of Patents and Trademarks of the United States of America and the empowered officials of all other governments, regional authorities, international organizations and others to issue or transfer all Letters Patent for the Patent Rights to ASSIGNEE, as assignee of the entire right, title, and interest therein or otherwise as ASSIGNEE**

may direct;

4. Binds the ASSIGNOR, any previous assignor, who has a legal obligation to ASSIGNOR to do so, and the heirs, legal representatives, successors and assigns of the previous assignor and the ASSIGNOR, as applicable, to do, upon ASSIGNEE's request and at ASSIGNEE's expense, but without additional consideration to ASSIGNOR, all acts reasonably serving to assure that the Patent Rights shall be held and enjoyed by ASSIGNEE as fully and entirely as the same could have been held and enjoyed by ASSIGNOR or the heirs, legal representatives, successors and assigns of the ASSIGNOR, as applicable, if this assignment had not been made; and particularly to execute and deliver to ASSIGNEE all lawful application documents including petitions, specifications, and oaths, and all assignments, disclaimers, and lawful affidavits in form and substance as may be requested by ASSIGNEE; to communicate to ASSIGNEE all facts known to ASSIGNOR relating to the Patent Rights or the history thereof; to furnish ASSIGNEE with any and all documents, photographs, models, samples, and other physical exhibits under the control of the ASSIGNOR, in the control of any previous assignor, who has a similar obligation to the ASSIGNOR, or the heirs, legal representatives, successors or assigns of the ASSIGNOR, as applicable, which may be useful for establishing the facts of conceptions, disclosures, and reduction to practice of the invention, discoveries, improvements and the Patent Rights; and to testify to the same in any interference, arbitration, or litigation with reasonable reimbursement as to expenses incurred as a result of such testimony; and

6. Authorizes the ASSIGNEE or the appointed agent of the ASSIGNEE to enter the Appl. Ser. No. and filing date of the patent application in the spaces provided herein.
