Patent Assignment

This PATENT ASSIGNMENT (the "Assignment") is entered into as of 10/8/2015 (the "Effective Date"), by and among Eric N. Wooldridge and Daniel B. Sellers hereby assign, transfer and convey (and agree to assign, transfer, and convey) to Buyer, and Buyer hereby accepts, all right, title, and interest throughout the world in and to: (a) U.S. Patent Application Serial No. 13/562,828, entitled "Vacuum Cooler" and having a filing date of July 31, 2012 (the "Patent Application"), and any issued patent or patent application that claims or is amended to claim priority, directly or indirectly, in whole or in part, to any of the above; (b) to the extent not included in (a), all issued patents, rights to inventions and pending and future applications for patents under U.S. law or regulation or of any foreign country with respect to the patentable inventions from which the Patent Application arises, including without limitation utility patents, utility models, design patents, invention certificates, continuations, divisionals, continuations-in-part, reexaminations, reissues, extensions and renewals, in all countries of the world (subcategories (a) and (b), collectively, the "Assigned Patents"); (c) all causes of action (whether known or unknown or whether currently pending, filed or otherwise) and other enforcement rights under or on account of the Assigned Patents including, without limitation, all causes of action and other enforcement rights for damages, injunctive relief, and any other remedies of any kind for past, current and future infringement; and (d) all rights to collect royalties or other payments under or on account of the Assigned Patents (subcategories (a), (b), (c) and (d), collectively, the "Assigned Patent Rights").

Sellers hereby assign, transfer and convey (and agree to assign, transfer, and convey) to Buyer: (a) all rights of cooperation assigned or granted by any third party and all rights to make applications for patents or other forms of protection for the Assigned Patent Rights (including without limitation the underlying inventions described therein) throughout the world, and empower and authorize Buyer to prosecute such applications as well as to claim and receive the

benefit of the right of priority provided by the International Convention for the Protection of Industrial Property, as amended, or by any similar or substitute convention or organization, including the right to invoke and claim such right of priority without further written or oral authorization; and (b) all rights to apply in any or all countries of the world for patents, certificates of invention, utility models, industrial design protections, design patent protections, or other governmental grants or issuances of any type related to any of the Assigned Patent Rights and the inventions, invention disclosures, and discoveries therein. Sellers hereby authorize the respective patent office or governmental agency to record the Assigned Patents in the name of Buyer as the assignee of the entire interest therein.

This Assignment may be executed in counterparts, each of which will be deemed an original, and all of which together constitute one and the same instrument. The terms and conditions of this Assignment will inure to the benefit of Buyer, its successors, assigns, and other legal representatives and will be binding upon Sellers, their successors, assigns, and other legal representatives.




