





It may also, but not prevalently, and for the sole purpose of pursuit of the principal activity, may take on, directly or indirectly, shareholdings and interests in other companies or businesses with a similar, like or connected mission, as well as undertaking any activity and effecting any industrial, business or financial, asset or property operation which the Managing Director or the Board of Directors may consider necessary or useful to the pursuit of the company mission, including the provision of personal and real surety, in favour of third parties, with the express exclusion of the collection of savings from the public and any financial operation not strictly connected with the industrial activities of the company, and especially, for example, any operation on financial instruments whether unquoted or admitted to trading in regulated markets and all that regulated by Legislative Decree no. 58 of 24 February 1998 and subsequent integration and modification.


