**RELEASE OF SECURITY INTEREST IN TRADEMARK, PATENT AND COPYRIGHT
COLLATERAL**

THIS RELEASE OF SECURITY INTEREST IN TRADEMARK, PATENT AND COPYRIGHT COLLATERAL (this "Release"), dated as of March 31, 2022, is made by Antares Capital LP, as Collateral Agent (the "Collateral Agent"), in favor of (i) Norwesco, LLC, a Minnesota limited liability company, (ii) Snyder Industries, LLC, a Nebraska limited liability company and (iii) Tank Holding Corp., a Delaware corporation (each, a "Grantor" and collectively, the "Grantors"). Capitalized terms used, but not otherwise defined herein, shall have the meanings set forth in the First and Second Lien Credit Agreements, the First and Second Lien Security Agreements or the applicable IP Security Agreement (each as defined below).

WITNESSETH:

WHEREAS, pursuant to that certain First Lien Credit Agreement, dated as of March 26, 2019, and that certain Second Lien Credit Agreement, dated as of March 26, 2019 (as amended, restated, supplemented or otherwise modified from time to time), collectively the "First and Second Lien Credit Agreements"), among Tank Holdings II LLC, a Delaware limited liability company, Tank Holding Corp., a Delaware corporation (as successor by merger to Tank Holdings II Merger Sub Corp.), the several lenders from time to time party thereto and Antares Capital LP, as the Administrative Agent and the Collateral Agent, and that certain First Lien Security Agreement, dated as of March 26, 2019, and that certain Second Lien Security Agreement, dated as of March 26, 2019 (together with all amendments, restatements, supplements and modifications, if any), collectively, the "First and Second Lien Security Agreements"), in each case, among the Grantors, the Collateral Agent and the other parties party thereto, the Grantors executed and delivered in favor of the Collateral Agent those certain Trademark Security Agreements, Patent Security Agreements and Copyright Security Agreement listed in Annex I attached hereto (collectively, the "IP Security Agreements"), which were recorded with the United States Patent and Trademark Office (the "USPTO") or United States Copyright Office (the "USCO"), as applicable, as specified in Annex I;

WHEREAS, pursuant to the First and Second Lien Security Agreements and the IP Security Agreements, each Grantor granted to the Collateral Agent, for the benefit of the Secured Parties, a lien on and security interest in, all of its right, title and interest in, to and under certain Intellectual Property, including Trademarks, Patents and Copyrights that was not Excluded Property, including those listed on Annex II attached hereto (collectively, the "Collateral");

WHEREAS, the Collateral Agent now desires to terminate and release the IP Security Agreements and the entirety of its Security Interest in the Collateral.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, and upon the terms set forth in this Release, the Collateral Agent, without recourse, representation or warranty and at the Grantors' sole cost and expense, hereby (i) terminates, cancels, releases, relinquishes, discharges and reassigns to the Grantors, in its entirety, for the benefit of the Grantors and their successors and assigns, its Security Interest in and to the Collateral, (ii) terminates and releases the IP Security Agreements described on Annex I attached hereto, and (iii) reassigns to each Grantor, any right, title or interest it may have in the Collateral of such Grantor. The Collateral Agent hereby authorizes the Grantors and their successors, assigns or other legal representatives to file this Release with the United States Patent and Trademark Office and the United States Copyright Office, at the sole expense of the Grantors, to evidence and effectuate the release and termination of the Collateral Agent's Security Interest in the Collateral.


