PATENT RELEASE AND REASSIGNMENT

THIS SECOND LIEN PATENT RELEASE AND REASSIGNMENT is made as of March 25, 2022, by The Northwestern Mutual Life Insurance Company, as Agent (in such capacity, "Agent"). Capitalized terms used but not defined herein shall have the same meanings assigned to such terms in the Security Agreement (as defined below).

W I T N E S S E T H:

WHEREAS, Cowboy Acquisition, LLC, a Delaware limited liability company (which merged with and into CSC Operating Company, LLC on October 13, 2020) (the "Grantor"), and Agent are parties to that certain Intellectual Property Security Agreement dated as of February 1, 2019 (the "Security Agreement"), pursuant to which Grantor granted to Agent a continuing security interest in and lien on the Patent Collateral (as defined below);

WHEREAS, the Security Agreement was recorded by the United States Patent and Trademark Office on February 1, 2019, at Reel 048223, Frame 0341;

WHEREAS, Grantor has requested that Agent release its security interest in and lien on the Patent Collateral and reassign any and all rights in the same to Grantor;

WHEREAS, Grantor has satisfied and fulfilled all of its obligations to release the Agent's security interest in and lien on the Patent Collateral.

NOW THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged:

1. Agent hereby releases, discharges, terminates and cancels its liens and security interest in all right, title and interest of the Grantor in, to and under the following:

(i) all of such Grantor's right, title and interest in, to and under its United States Patent applications and registrations, including, without limitation, those listed on Schedule I attached hereto (the "Patent Collateral");

(ii) all reissues, reexaminations, continuations, continuations-in-part, divisionals, renewals and extensions of the Patent Collateral;

(iii) all income, royalties, proceeds and Liabilities at any time due or payable or asserted under and with respect to Patent Collateral, including, without limitation, all causes of action and rights to sue and recover at law or in equity for any past, present and future infringement, misappropriation, dilution, violation or other impairment thereof.

2. Agent hereby reassigns, grants and conveys to Grantor, without any representation, recourse or undertaking by Agent, any and all of Agent's right, title and interest in and to the Patent Collateral.
