## RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY

This RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY (this "Release"), dated as of April 5, 2022, is made by SLR INVESTMENT CORP. (in such capacity, "Agent") in its capacity as collateral agent for the Lenders in favor of SOC TELEMED, INC., a Delaware corporation (the "Grantor"). All capitalized terms used but not defined herein shall have the respective meanings given to them (including by reference) in the Loan Agreement.

**WHEREAS**, the Grantor, the other grantors party thereto and the Agent entered into a Loan and Security Agreement, dated as of March 26, 2021 (as amended, restated, or otherwise modified from time to time, the "Loan Agreement"), pursuant to which the Grantor and each domestic Subsidiary signatory thereto executed and delivered to the Agent that certain Intellectual Property Security Agreement, dated as of March 26, 2021 (the "Intellectual Property Security Agreement");

**WHEREAS**, pursuant to the Loan Agreement and the Intellectual Property Security Agreement, the Grantor pledged and granted to the Agent for its benefit and for the benefit of the Lenders a security interest in all of the Grantor's right, title and interest in, to and under its intellectual property, other than Excluded Property (collectively, the "Intellectual Property Collateral"), including, without limitation, the following (in each case, other than Excluded Property):

(a) Any and all copyright rights, copyright applications, copyright registrations and like protections in each work of authorship and derivative work thereof, whether published or unpublished and whether or not the same also constitutes a trade secret, now or hereafter existing, created, acquired or held, including without limitation those set forth on Exhibit A attached hereto (collectively, the "Copyrights");

(b) Any and all trade secrets, trade secret rights, including, without limitation, any rights to unpatented inventions, know how, and operating manuals and any and all intellectual property rights in computer software and computer software products, in each case now or hereafter existing, created, acquired or held;

(c) Any and all design rights that may be available to Grantor now or hereafter existing, created, acquired or held;

(d) All patents, patent applications and like protections including, without limitation, improvements, divisions, continuations, renewals, reissues, extensions, re-examination certificates, utility models, and continuations-in-part of the same, now or hereafter existing, created, acquired or held, including without limitation the patents and patent applications set forth on Exhibit B attached hereto (collectively, the "Patents");

(e) Any trademark and servicemark rights, whether registered or not, applications to register and registrations of the same and like protections, and the entire goodwill of the business of Grantor and each of its Subsidiaries connected with and symbolized by such trademarks, now or hereafter existing, created, acquired or held, including without limitation those set forth on Exhibit C attached hereto (collectively, the "Trademarks");

(f) All mask works or similar rights available for the protection of semiconductor chips, now after acquired, including, without limitation those set forth on Exhibit D attached hereto (collectively, "Mask Works");

(g) Any and all claims for damages by way of past, present and future infringements of any of the rights included above, with the right, but not the obligation, to sue for and collect such damages for said use or infringement of the intellectual property rights identified above;

(h) All licenses or other rights to use any of the Copyrights, Patents, Trademarks, or Mask Works and all license fees and royalties arising from such use to the extent permitted by such license or rights;

(i) All amendments, renewals and extensions of any of the Copyrights, Trademarks, Patents, or Mask Works; and

(j) All proceeds and products of the foregoing, including without limitation all payments under insurance or any indemnity or warranty payable in respect of any of the foregoing.


**WHEREAS**, the Intellectual Property Security Agreement was recorded with the United States Patent and Trademark Office on March 29, 2021 at Reel 7235, Frame 0543 and at Reel 055751, Frame 0310; and

**WHEREAS**, the Grantor has requested that the Agent execute and deliver this Release to evidence the release of its security interest in the Intellectual Property Collateral for recordation at the United States Patent and Trademark Office.

**NOW, THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Agent, without any representation, warranty or recourse of any kind or nature, hereby (a) releases its security interest in the Intellectual Property Collateral, and (b) terminates the Intellectual Property Security Agreement.
