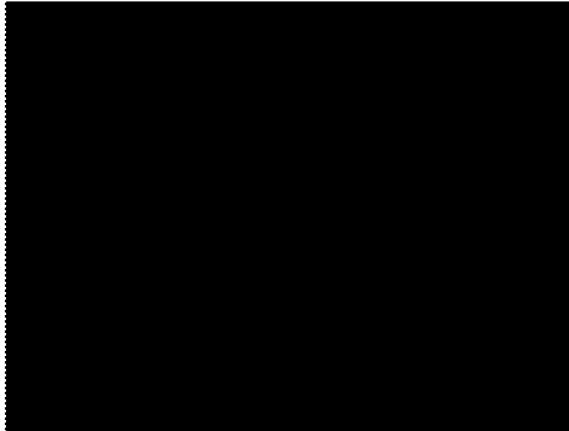

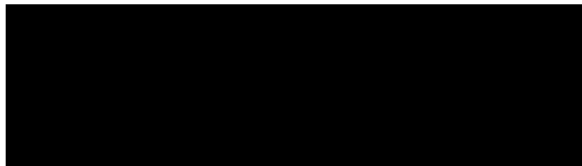
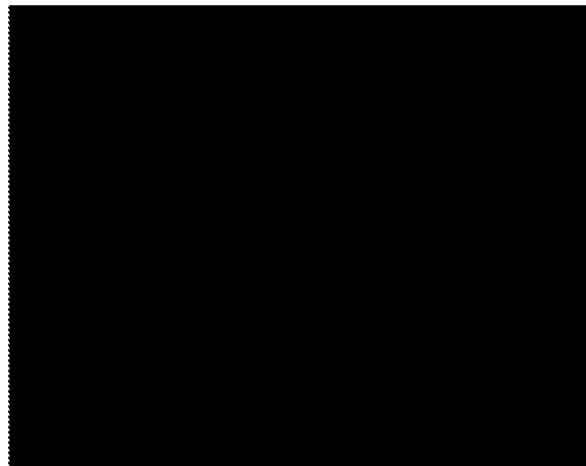
CERNER ASSOCIATE EMPLOYMENT AGREEMENT

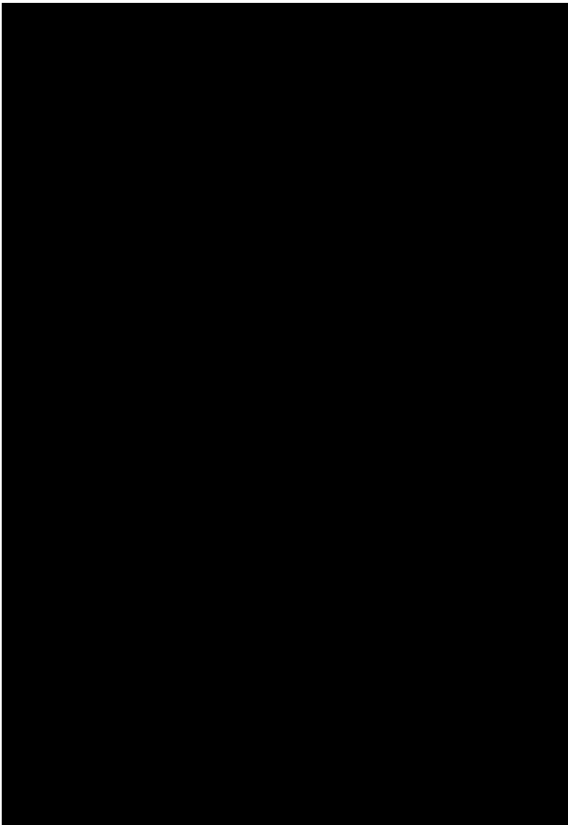

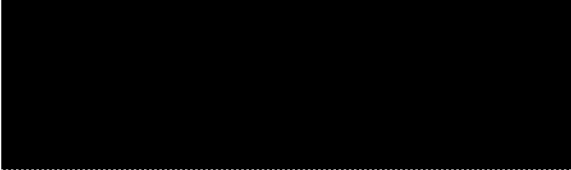

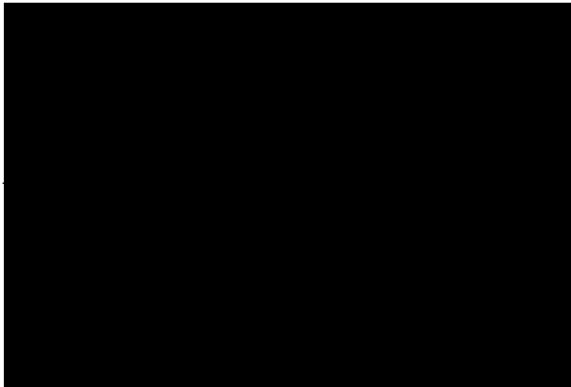
You expressly acknowledge that this provision also applies to all Work Product which relates to Labotix that was developed during your employment with Labotix.
